Graduate Credit Requirements: Attend a total of twelve (12) events. You may include no more than four (4) concerts toward meeting this requirement. For example: 12 Clinic Sessions, 11 Clinic Sessions and 1 Concert, 10 Clinic Sessions and 2 Concerts, etc.

Using the required template (below), submit a typed synopsis to pd_director@omea-ohio.org by February 22.

Your paper should include:

- Name
- Teaching Area(s)
- Years of Experience
- Email Address

For each concert performance (max of four), please include ensemble name, day, room and performance time. Please include a general review of the performance including programming, pacing, educational value and any application to your unique teaching situation. This is not an adjudicated event. You do not need to list all of the mistakes you hear or critique the ensemble in great detail. Please keep your comments professional.

Important - please number the reflections from 1-12. Concert reflections, (max of 4), should be listed first. Please copy and paste this table at the beginning of each session reflection, (do not use for concerts). 1=Low, 5=High

Reflections deemed unsatisfactory will be given one opportunity to resubmit. The credit is offered on a S/U basis.
